- You **MUST** put down preferred dates or your application will be denied
- This category is for food vendors that are suitable for the market & in line with market values and guidelines.
- New applicants will be in the new vendor area unless otherwise notified
- Applicants are accepted on a trial basis for the season and at the discretion of the Market Manager.
- Spaces are assigned based on availability and market needs. Applicants are reviewed by the GFM Committee and will be accepted or denied based on our policies and criteria for suitability with a Producer-based Farmers' Market. All decisions are final.
- Fees are non-refundable; however, rain-dates can be arranged for **non-seasonal prepaid** vendors.

There is no on-street parking for the duration of the market.

Anchor weights are REQUIRED for all tents at the Market in case of inclement weather. If you do not have them you cannot set up a canopy!

There is NO SMOKING on Main Street! If you need to smoke, please move away from other vendors and customers
